En uso de sus facultades legales, en especial las conferidas por el Artículo 101°, de la Ley 270 de 1996 “Estatutaria de la Administración de Justicia” y en el acuerdo No. PSAA05-3261 de 2005, y

CONSIDERANDO:

Que mediante Acuerdo CSJVA 15-75 de diciembre 15 de 2015, se estableció los turnos para ejercer la Función de Control de Garantías del Sistema Penal Oral Acusatorio, para los Juzgados Penales Municipales con Funciones de Control de Garantías de los Distritos Judiciales de Cali y Buga, durante los meses de febrero a junio de 2016.

Que en los cuadros anexos, que corresponden a la referida programación, se incurrió en un error al momento de programar los turnos en el mes de marzo, más precisamente en la Semana Santa, pues, no se dieron los correspondientes compensatorios, a los Despachos Judiciales que laboraran durante dicha semana.

Que dada la anterior circunstancia, se hace necesario corregir los yerros relacionados con la compensación de días no programados.

ACUERDA:

ARTÍCULO 1°. Modificar el Acuerdo CSJVA-075 del 15 de diciembre de 2015, que estableció los turnos para ejercer la Función de Control de Garantías, durante los meses de febrero a junio de 2016, para los Juzgados Penales Municipales del Sistema Penal Acusatorio de los Distritos Judiciales de Cali y Buga, de acuerdo con lo previsto en los cronogramas anexos al presente Acuerdo.
