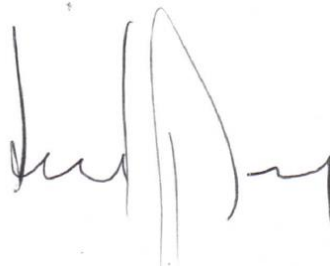
Igualmente, se le imparte APROBACION a la liquidación de costas visible a fl. 57 de esta encuadernación.

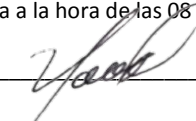
